## RULES & REGULATIONS

Your enjoyment of the Eagle Point Golf Club (EPGC) and its associated resort offerings is our main priority. While we expect membership access to be a dual benefit, specific details regarding your membership must be reiterated to ensure mutual agreement and satisfaction for all members and guests.

- Membership is valid for an initial term 12-months from the date of purchase. If you elect to cancel your membership for any reason during the initial 12-month term, you will be obligated for the remaining term, regardless of payment method. After the initial term, the membership shall continue on a month-to-month basis and **may be canceled by either party with 30-days' written notice to the General Manager.**
- Family membership includes spouse and dependent children (attending school) under the age of 22-yrs. living in the same household.
- Tee times are subject to availability depending on EPGC activities and events.
- All members and guests *must* check into the Golf Shop ten minutes prior to tee time.
- **Powered Carts:** Members and guests are asked to double up in carts whenever possible to limit cart traffic and wear and tear on the golf course. Member or guest riding in another's private golf cart is still responsible for ½ cart fee and can be paid in the Golf Shop prior to beginning play. Riders (non-playing guests) are subject to the same guest cart fee. A member or guest may elect to ride individually and will be subject to the full cart fee.
- Carts are only to be driven by persons 18-years old and older and must have a valid driver's license.
- Persons with a medical need may request and apply for "Blue Flag" considerations. Annual approval may be granted upon request and receipt of a medical doctor's note.
- Children under seven (7) years of age not permitted unless playing golf with an accompanying adult.
- Membership Medical Leave of Absence (LOA) or other specialty needs must be communicated and approved in writing by the General Manager. Members approved for a LOA are required to be an active member in good standing for twelve (12) months following before any subsequent LOA will be approved.
- Membership benefits and/or dues, green fees, cart fees or range fees are subject to periodic change. Significant notices should be communicated and posted 30-days in advance for members and guests.
- Membership and its benefits are not transferable and have no cash value.

- At EPGC and/or the Resort at Eagle Point, discrimination, harassment or bullying on the basis of race, color, creed, religion, sex, natural origin, age, disability, sexual orientation, or any other protected category, whether verbal, physical or environmental, is unacceptable and will not be tolerated. This harassment policy covers all Team Members, Members and Resort Guests. EPGC will not tolerate, condone or allow unlawful harassment, whether engaged in by fellow Team Members, supervisors, clients, vendors, customers or other entities who conduct business with us.
- Members *must* abide by all golf course rules and regulations to remain in good standing.
- Eagle Point Golf Club reserves the right to revoke, revise or modify membership programs at any time with or without prior notice.

**Dress Code:** Proper casual golf attire is requested. Soft spike shoes only. Denim is discouraged on golf course(s) but acceptable in all other resort areas.

**Fivesomes:** Fivesomes are permitted seasonally with permission from golf management and are expected to complete the round in 4:20 hours or less, or within 9-minutes of the group immediately in front of them. Fivesomes pace of play will be monitored and documented.

**Etiquette:** For the enjoyment of all Members, Resort Guests and Team Members, proper etiquette on and around the clubhouse and practice areas is expected. Golf was meant to be FUN – enjoy yourself responsibly.

Members, and their guests, agree to comply with and be bound by all of the covenants and conditions, regulations and bylaws of this membership agreement and of the EPGC as they are currently stated and as they may be modified or amended. Failure to comply will result in the termination of the membership.

Any unresolved disputes between the EPGC and a member shall be submitted to binding arbitration proceedings in accordance with the provisions of ORS36.300 et seq. The non-prevailing party shall bear the expense of the arbitration proceeding, unless arbitration determines otherwise.
